Dear Mr. Baranga:

This letter serves as notification of registration for the pesticide-producing establishment for which you applied, according to Section 7 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA).

The U.S. Environmental Protection Agency assigns every company a unique company number. BioPledge, LLC is assigned the EPA company number 91691. Each establishment which a company registers to produce pesticides or pesticidal devices is assigned a unique EPA Establishment Registration Number. The EPA Est. No. **91691-TX-1** refers to the establishment that was activated for the BioPledge, LLC located at 2300 McDermott, Ste 200-381 in Plano, TX. This establishment registration will remain in effect provided pesticide reports on production and sales or distribution amounts are submitted annually as required.

40 C.F.R Part 167 requires your company **to submit an Initial report for each Pesticide-Producing Establishment within 30 days of receipt of this letter using EPA Form 3540-16.** Failure to submit your initial report within a timely manner may subject your company to an administrative civil penalty. After the Initial Report, future reports must be submitted on an annual basis. BioPledge, LLC is responsible for submitting this report every year, for each active establishment, even if a reminder is not received by the company headquarters. Production reports for establishments registered to produce pesticides and pesticidal devices are due by March 1, as long as the establishment is active, regardless of whether or not production has occurred.

Non-compliance with this reporting requirement more than once in a five year period usually subjects producing establishments to an administrative civil penalty up to \$7,500 and/or termination as described in the May 2010, Enforcement Response Policy for FIFRA Section 7(c) violations.

EPA Form 3540-16 and instructions for filling out the form are available online at the EPA website listed below. If you have difficulty accessing the form and instructions online, please contact me and I will provide you with the necessary forms.

EPA has developed an electronic reporting system for the submission of the Annual Pesticide Report. The system is now fully operational and companies can register to submit report(s) electronically at https://cdx.epa.gov/. If this interests you, please contact me for more information.

Changes in name, address, or ownership of the company or any establishments are to be reported to EPA Headquarters and to this office within thirty (30) days of the change. For more information on how to report a change in company information, see the following website:

If your company decides to cease production of all pesticides and pesticidal-devices, you may request inactivation of an establishment. Requests for inactivation of establishments are also to be sent to this office.

For your information, on August 16, 2006, EPA published in the Federal Register (71 FR 47330 – 47437) the final rule, "Pesticide Management and Disposal; Standards for Pesticide Containers and Containment" (Rule). The Rule establishes requirements for non-refillable containers; refillable containers; repackaging pesticide products; container labeling; and containment structures and is codified in the Code of Federal Regulations at Title 40 Subpart 165. Please make sure you are aware of the Rule and how it applies to your facility.

KEEP THIS LETTER FOR YOUR RECORDS. DO NOT RETURN IT WITH THE INITIAL REPORT. This is your official documentation that your Establishment has been registered with EPA. (Section 7 FIFRA)

IMPORTANT INFORMATION

The State office which regulates pesticides in your state has the authority to inspect your production Establishment at any time without prior notification. (Section 8 FIFRA)
